

1. Opening remarks by AONSA President Wen-Hsien Li

AONSA President Wen-Hsien Li welcomed all members and observers to Sydney.

2. Approval of Agenda

The Agenda of the 14th AONSA EC meeting was approved by the EC.

3. Approval of Minutes of the 13th AONSA EC Meeting

The Minutes of the 13th AONSA EC meeting in Serpong, Indonesia, which was circulated to the EC members and observers through email previously, were distributed to all the EC participants as hard copies at the meeting. The minutes were approved.

4. Discussions and formal matters

4.1. Gender balance in the Asia-Oceania neutron scattering community

Kirrily Rule (ANSTO) gave a presentation on gender balance in the Asia-Oceania neutron scattering community, comprising data compiled by ANSTO staff and by the organisers of the second AOCNS (**Appendix 1**). The considerable effort involved in compiling these data was greatly appreciated, and a commitment to encouraging and facilitating female participation in this field was expressed. The diversity policy ultimately adopted for the second AOCNS will be used as the basis for a similar policy at the third AOCNS and at ICNS-2017. It is hoped that AONSA regional societies will encourage female members to register with the database being compiled as part of the NMI-3 project.

4.2. Financial matters

The AONSA financial report for 2014 (**Appendix 2**) and budget plan for 2015 (**Appendix 3**) were presented by Yuntao Liu on behalf of the AONSA Treasurer, Dongfeng Chen. The budget plan was approved by the EC. A summary of the impact of the AONSA Young Research Fellow program was also presented (**Appendix 4**).

4.3. AONSA Prize

Sung-Min Choi presented a report on the AONSA Prize 2015 (**Appendix 5**).

4.4. Asia-Oceania Conference on Neutron Scattering

Presentations were delivered by the three bidders to host the 3rd AOCNS in 2019: CNSS (by Hesheng Chen), NSSI (by Surendra Singh) and TWNSS (by Hsiung Chou). According to the rules, each bidder was given 15 minutes to make their presentation, followed by questions. Am anonymous ballot was then conducted, in which each of the EC members could vote (2 representatives of each full member society, plus the President).

The results were: TWNSS 6 votes; CNSS 5 votes; NSSI 1 vote.

TWNSS was therefore confirmed as the host of the 3rd AOCNS in 2019.

4.5. AONSA Neutron School

Hideki Seto presented a report on preparations for the 7th AONSA Neutron School in 2015 in Tokai, Japan (**Appendix 6**).

Surendra Singh presented the proposal by NSSI to host the 8th AONSA Neutron School in October 2016 in India (**Appendix 7**). There being no other proposal to host this School, the proposal was accepted and NSSI confirmed as the host of the 8th AONSA Neutron School.

4.6. AONSA Young Research Fellows

Sung-Min Choi presented a report on the current status of the AONSA YRF 2015 and the schedule for the AONSA YRF 2016 (**Appendix 8**). It was noted that according to the rules, the nominations for the next year should be confirmed by the end November; however, the next EC meeting will take place on December 4. It was therefore proposed and accepted that the nominations would be conveyed to EC members before the end of November, and that final confirmation would take place at the EC meeting on December 4.

It was also noted that only two facilities will be able to host AONSA YRF in 2016: ANSTO and J-PARC. ANSTO has offered to host up to two AONSA YRF in 2016, under these exceptional circumstances.

4.7. ICNS2017 in Korea

Sung-Min Choi reported on the status of preparations for ICNS2017 in Korea (Appendix 9).

4.8. AONSA Newsletters and Homepage

Hideki Seto presented the report of the Public Relations Officer (**Appendix 10**). It was noted that contributions to the next Newsletter will be required by August 17, 2015.

4.9. Cooperation with ICSU, IUCr and IAEA

Wen-Hsien Li thanked the IAEA and IUCr for their continuing support of AONSA activitieds, including AOCNS-2015 and the 5th AONSA Neutron School.

4.10. Cooperation with NSSA and ENSA

Christiane Alba-Simionesco thanked AONSA for its Letter of Support concerning the shutdown of Saclay (**Appendix 11**). She reported that the shutdown is still planned for the end of 2019, and noted that this is part of a broader challenge for the future of neutron scattering in Europe, together the shutdown of the Berlin reactor, uncertainties over the future of PSI, and the eventual lifetime limits on the ILL (around 2030).

4.11. Cooperation Association of Asia-Pacific Physical Societies (AAPPS)

Yasuhiko Fujii presented a summary of the history and activities of AAPPS (Appendix 12).

4.12. Venue for the 15th, 16th and 17th EC Meetings

The 15th AONSA EC meeting will be held in Tokai, Japan, on December 4, 2015. The venue for the 16th EC meeting will be decided at this time.
