

#### **Minutes**

The meeting opened at 0905 on May 31, 2016.

AONSA President Sung-Min Choi welcomed participants to the 16<sup>th</sup> Executive Committee meeting, and thanked the organisers in Dongguan. He extended a particular welcome Prof Darminto, representing the Indonesian Neutron Scattering Society (INSS) as a formal member of AONSA for the first time.

The AONSA Secretary, Chris Ling, formally presented the Agenda and the Minutes of the previous meeting, which were accepted unanimously. He noted a change in the AONSA Office whereby Chiyoko Yanada would now work alongside Chikako Doda. Hideki Seto would continue to act in a liaison role between the Office and the EC. Sung-Min Choi thanked Hideki Seto, and also Toshiji Kanaya for continuing to allow the AONSA Office to operate at J-PARC.

#### **Formal matters**

Sung-Min Choi first noted the passing of Prof Sutiarso, and extended his condolences to his family and friends. This was a great shock and loss, and he would be missed by the AONSA community. Darminto also spoke of the loss to the Indonesian community in particular, and noted that he was himself a classmate of Sutiarso. An *in memoriam* prepared by Edy Giri Rachman Putra is presented in Appendix 2.

Sung-Min Choi presented a proposal to define the Duties of Members-at-Large on the AONSA Board. Specifically, the Proposed Duty Statement to be added to the AONSA Rules was:

"The Members-at-Large shall participate in Board discussions and shall perform such duties as the Executive Committee or Board may assign."

This proposal was accepted unanimously. Chris Ling implemented the change on the AONSA website.

In response to the increased number of member societies of AONSA from 6 to 7, AONSA Vice-President Kazuyoshi Yamada (Chair of Selection Committees for AONSA Award and

Young Research Fellows) introduced a proposal to increase the number of Selection Committee Members for the AONSA Prize and YRF. Specifically, the proposal was to change the Rule for the AONSA Prize and YRF from:

"3a. The SC shall consist of six members chaired by the AONSA Vice President while other four members shall be appointed by the EC. Their term shall be two years (one selection cycle). A member can be reappointed for the next selection cycle (up to two cycles for four years)."

to

"3a. The SC shall consist of seven members. The Chair shall be the AONSA Vice President and the other six members shall be appointed by the EC. Their term shall be two years (one selection cycle). A member can be reappointed for the next selection cycle (up to two cycles for four years)."

This proposal was accepted unanimously. Chris Ling implemented the change on the AONSA website.

#### **Financial matters**

AONSA Treasurer Dongfeng Chen presented the Annual Fee and Budget Plan (Appendix 3) and the AONSA Prize Fund and Budget Plan (Appendix 4). He thanked Chikako Doda from the AONSA Office for her invaluable help, and noted that he had engaged a professional financial expert this year to ensure that all the accounts were in order.

The financial reports were accepted unanimously. Sung-Min Choi thanked Dongfeng Chen and noted that the expenses for the YRF were \$2000 lower than expected in 2016 due to the withdrawal of one awardee.

#### AONSA Prize 2017 (K Yamada)

AONSA Vice President Kazuyoshi Yamada reported on nominations for the Selection Committee for the AONSA Prize 2017 (Appendix 5). Nominations would be called for in mid-June 2016, with a deadline mid-August. The Prize would be awarded at ICNS-2017 in Korea.

#### **AONSA Young Research Fellows**

Kazuyoshi Yamada reported on nominations for the Selection Committee for the AONSA YRF 2017 (Appendix 6). Nominations would be called for in mid-June 2016, with a deadline at the end of August.

#### Asia-Oceania Conference on Neutron Scattering

Hsiung Chou reported in the status of TWNSS preparations to host AOCNS-2019 (Appendix 7). The conference will take place from 11-15 November, 2019.

#### **AONSA Neutron School**

Secretary Chris Ling presented Saibal Basu's report (in his absence) on NSSI preparations for the 8th AONSA school to be held in India in October 2016 (Appendix 8). Toshiji Kanaya noted that the MLF School (which is also an international neutron school) would be held in Japan the following week.

#### ICNS2017 in Korea

Jae-Ho Chung presented a report from the organizers of the ICNS2017 meeting in Korea (Appendix 9).

#### **AONSA Newsletters and Homepage**

AONSA Public Relations Officer Hsiung Chou presented a report on the AONSA Newsletter and Homepage (Appendix 10).

#### Activities Related to SE Asia and Other Non-member Countries

Sung-Min Choi noted that the Thai community was still intending to host a AONSA EC and FDM in 2017. He also noted that a new Observer would be welcome from the Singapore community; Chris Ling undertook to make enquiries about a suitable candidate. Finally, Sung-Min Choi noted that one application for the YRF in 2016 was received from Vietnam, although this applicant was unfortunately not eligible due to not having a PhD.

#### **Neutron Facility Directors Meeting**

AONSA FDM Chair Yuntao Liu presented the Report on the 11th FDM (Appendix 11).

### Calendar of AONSA Activities

Chris Ling presented the current state of the AONSA Calendar (Appendix 1).

## Venue for the 17<sup>th</sup>, 18<sup>th</sup> and 19<sup>th</sup> EC Meetings

The 17<sup>th</sup>, 18<sup>th</sup> and 19<sup>th</sup> EC Meetings will be held in India, Korea and Thailand respectively.
